

[FAQ] (SK-FIT) Scholarship & Financial Aid

1. **Question:** May I apply for both scholarship and financial aid?

Answer: Yes.

2. **Question:** I will attend the school next semester as a part-time (under 12 credits) enrolled student. Can I apply?

Answer: Yes. If you are enrolled full-time this semester. For example, if you are enrolled full-time in Fall 2022, you may apply for scholarship and/or financial aid for Spring 2023. Please note that any type of scholarship / financial aid you may receive as a part-time student will match and not exceed the part-time tuition.

3. **Question:** I received an email that my scholarship / financial aid will be renewed next semester as it is planned for 2 (or 8) semesters. Do I have to apply again?

Answer: No. However, you are required to submit the Self-evaluation Report and other related reports (refer to the list below) for this semester. Please keep in mind that your scholarship / financial aid may be terminated if you do not submit the reports on time.

※ Self-evaluation Report is required for all recipients of scholarship and financial aid.

※ If you are the recipient of the Presidential Scholarship, Provost Scholarship enrolled in your graduating semester you are required to submit a Vision Statement Report by the end of the graduating semester.

4. **Question:** A few years ago, I got an email that I would be the recipient of the scholarship / financial aid but I took a leave of absence until last semester. What should I do?

Answer: You should submit the General Petition form to your department coordinator. As you receive academic advising for readmission, your department coordinator will also provide information about scholarship / financial reinstatement processes.

5. **Question:** I am currently on a leave of absence and will readmitting next semester. Can I apply for the scholarship / financial aid?

Answer: Yes.

6. **Question:** I do not know my GPA for this semester yet. How can I apply for the scholarship / financial aid?

Answer: Please apply when your GPA becomes available for this semester.

7. **Question:** I am a recipient of a new student scholarship / financial aid but I want to apply for the scholarship / financial aid for continuing Students. Can I apply?

Answer: Sure. If your application gets selected for scholarship / financial aid for continuing students, you will receive the larger amount of scholarship / financial aid between the new student's and the continuing student's scholarship / financial aid. The term in which these scholarships are applied will still be counted towards the recipient's original scholarship maximum renewal period.

8. **Question:** If I'm applying for financial aid, should I submit proof of yearly income for both of my parents/guardians?

Answer: Yes. If you are applying for financial aid, you should submit proof of yearly income for both of your parents/guardians. For a list of required documents, please refer to the Scholarship Guideline.

9. **Question:** When we submit the 'Certificate of Income and Certificate of National Health Insurance Fee of both parents' for the financial aid document, could we send the documents from Year 2021?

Answer: Yes. You can send the documents from Year 2021.
